We also recommend that an additional subparagraph is added to Policy CHW01 to reflect the NPPF's commitment to positive and collaborative working with school promoters:

"The Council will adopt a proactive, positive and collaborative approach to working with school promoters through pre-application discussions and planning applications to support the delivery of new and expanded educational facilities."

Following earlier representations (dated August 2021) submitted on behalf of Queen Elizabeth's School to the Regulation 19 consultation, the proposed modifications to the Plan do not take forward our request to include appropriate provisions in Site 45's (Land adjoining Whalebones) allocation text to manage the construction and operational impact of the development proposed. This is important to protect against undue impacts upon the School's operation and to ensure pupil safety is maintained.
