

The London Borough of Barnet (Brent Cross Cricklewood) Compulsory Purchase Order (No.2) 2015

The Town and Country Planning Act 1990 and the Acquisition of Land Act 1981

The London Borough of Barnet (in this Order called the “acquiring authority”) makes the following Order: -

1. Subject to the provisions of this Order, the acquiring authority is under section 226(1)(a) of the Town and Country Planning Act 1990 hereby authorised to purchase compulsorily the land described in paragraph 2 for the purposes of facilitating its development, redevelopment or improvement by way of a mixed-use scheme comprising retail development; community facilities; residential development; leisure development; car parking; infrastructure and highway works, and public realm and environmental improvement works, thereby contributing towards the promotion and/or the improvement of the economic, social and environmental well-being of the area.
2. The land authorised to be purchased compulsorily under this Order is the land described in the Schedule and delineated and shown coloured pink and edged red on the map prepared in duplicate, sealed with the common seal of the acquiring authority and marked “Map referred to in the London Borough of Barnet (Brent Cross Cricklewood) Compulsory Purchase Order (No. 2) 2015”.
3. After the stated area of each plot in the column headed “Extent, description and situation of the land (2)” in this Order the words “or thereabouts” shall be taken to follow the words “square metres”.
