- The land described in the Schedule hereto (being part of the land authorised to be acquired by the order) and more delineated on plan annexed hereto, together with the right to enter and take possession of the land shall vest in the Authority as from the of the period of 19 weeks from the date on which the service of notices required by section of the Act is completed.
- 2. For the purposes of section 2(2) of the Act, the specified period in relation to the land comprised in this Declaration is one year and one day.
